### Terms of Use

1) Agreement and Acceptance of Terms

Welcome to Marstone, LLC! Marstone, LLC ("Marstone") is an investment adviser and digital advisory service. By accessing or using the Marstone website, <u>www.wealth.marstone.com</u> and/or our mobile applications, ("Marstone Website") you agree to be bound by the terms and conditions ("Terms of Use" or "Agreement") set forth below and Marstone's Privacy Policy, now existing, or as may be amended from time to time. If at any time you disagree with this Terms of Use, you should not access or use the Marstone information, content, tools, software, features and functionality located on www.wealth.marstone.com (the "Service").

BY ACCESSING THE SERVICE, YOU ACKNOWLEDGE THAT YOU HAVE READ, UNDERSTOOD AND AGREE TO BE BOUND BY THIS AGREEMENT. Upon termination of this Agreement, Marstone shall be under no obligation to recommend any action with regard to, or to liquidate, the securities or other investments in your Investment Account. Upon termination, it shall be your exclusive responsibility to issue appropriate disposition instructions in writing regarding any assets in your Investment Account.

13) Governing Law; Jurisdiction and Venue

This Agreement, and your relationship with Marstone under this Agreement, shall be governed in all respects by the laws of the State of Delaware as such laws are applied to agreements between parties in Delaware.
